MEMORANDUM OF UNDERSTANDING

Between

Gandhi Gyan Mandir Yoga Kendra (society) here in after called as 'Yoga Kendra'
Tilak Road, Sultan Bazar, Hyderabad

AND

HMV here in after called as 'College'
Nallakunta, Hyderabad

The general objective of this Memorandum of Understanding (MOU) is for the development of academic cooperation in YOGA EDUCATION and to stimulate, facilitate the Development of collaborative and mutually beneficial program which serve to enhance the intellectual life and cultural development in both organizations. Thus, the Yoga Kendra and HMV have agreed the following in support of their mutual interests.

The parties mutually agree to the following terms and conditions:

1. The Yoga Kendra Gandhi Gyan Mandir Yoga Kendra agrees to provide practical Orientation on Yoga to the Students as and when required during the course.
2. The Yoga Kendra agrees to brief the students at regular intervals through lectures.
3. The Yoga Kendra agrees to provide assistance in placement of the students after successful completion of the program
4. This MOU begins on the effective date and expires on one year from the date of this agreement, with a notice period of one month, unless terminated earlier, in accordance with the MOU.
5. This MOU in no way restrict the Yoga Kendra and HMV from participating in similar activities with other private or public agencies, organizations or individuals.
6. Each party, upon 30 days of written notice, may terminate the MOU in whole or in part at any time before the expiration of the MOU without liability to the other party. Further either party may terminate the MOU, if the other party is in the breach of this MOU and fails to cure such breach within 10 days after written notice of the breach.

7. The Yoga Kendra shall designate one of its employees as the center coordinator at the cost of college. The center coordinator shall act as the administrative liaison to the college in implementing the terms of this Agreement.
8. The College recognizes the shared responsibility it has with the Yoga Kendra to abide by various regulations.
9. Neither the Yoga Kendra nor college will discriminate against any individual on the basis of age, creed, race, color, handicap, sex or national origin in connection with the program.

This Agreement constitutes the entire Agreement between the College and Yoga Kendra and superseded all proposals or prior agreements, oral or written, and all other communications, oral or written. This agreement shall not be amended, altered or changed except by written agreement of both parties.
