### INSTITUTIONAL ETHICS COMMITTEE

Research Innovation and Extension committee advises all Faculty and Students involved in research activity to adhere strictly to the Code of Ethics

The Code of Ethics provides a set of practical suggestions for maintaining integrity and quality in research. This code aims to satisfy a scientific moral code and improves scientific results including qualitative analysis, quantitative & statistical techniques. It is set to help Researcher avoid departures from accepted ethical research practice and prevent from research misconduct like wilful fabrication, falsification, or plagiarism including misrepresentation of credentials in proposing, performing, or reviewing research or in reporting research results. It does not include honest error or differences of opinion.

These guidelines are framed to caution and orient all researchers in research ethics. Screening committee of R & D looks into all matters relating to publication of research articles by researchers and scholars.

### ROLE OF ETHICS COMMITTEE

- Review and approvals of all types of research proposals involving human participants.
- Safe guard the dignity, rights safety and wellbeing of human participants.
- Follows the principles of research ethics, autonomy, justice in planning conducting and reporting the proposed project.
- Reviews the proposals before the start of project and periodic reviews for monitoring the research throughout the study.
- Looks into preparation of consent forms, risk/benefit ratio.
- Frames guidelines and checks into regulatory requirements and plagiarism.
- The institutional Head, (Principal of college) will nominate the IEC by appointing scientific and non-scientific members. The expertise, experience and qualification will be taken into consideration for appointment of members.
- Formulate and publish ethical guidelines are simple to understand and acceptable.
- Provide a mechanism for consultation on urgent ethical problems.
- Ethical review of research proposals.
- To meet annually to review the policies.
